• DC H Crane read out her report. DC P Bate circulated his report prior to the meeting. Both reports will be on the website. Vice-Chair C Spinks asked for an update on devolution. DC H Crane said that Breckland are in disagreement with NCC when it comes to being single unitary or three part unitary devolution. If it goes into a single unitary, council tax will go up drastically for the Breckland area. Three unitaries would be the best option for Breckland as this would mean joining with Kings Lynn and West Norfolk and there is a pre-existing relationship with these County Councils. There are still ways for public to get involved to express their opinions.

## 9. Update on the dog waste bin

 The dog waste bin has been installed – The clerk has notified Environmental Waste to begin collecting it.

## 10. Update on the bench installation

No progress as of yet as the hedge/trees needs to be cleared first. Cllr. N Mobbs informed the
council that the owners had put in a request to cut the trees around the area, but NCC won't give

permission for these trees to be cut. Scoulton Parish Council have concerns about these trees encroaching on electric wires. Clerk to contact the BTInternet/Telephone/Internet company to request these trees be cut back.

# 11. To discuss and decide if Scoulton Parish Council wish to change banks due to Lloyd's introduction of an unavoidable monthly service charge of £4.25

 After a discussion, Cllr. K Stevens proposed to stay with Lloyds. Cllr. M Brown seconded and passed unanimously.

## 12. Footpaths

• The clerk updated the Parish Council that the landowner is not open to maintaining the proposed footpath and is concerned about the location. Cllr. N Mobbs proposed to state that the Parish Council has pursued this project as far as they can. Seconded by Cllr. N Webster. Agreed unanimously. Clerk to notify the landowner and express thanks for their involvement up to this point.

## 13. Any Village and Highways Issues

- Cllr. M Brown informed the PC that the sleepers around the village sign are falling down and need replacing or removing. There is concern over the health of the post if the sleepers are taken away. The sign will be inspected and this topic will be put on the next agenda.
- There was a discussion over flora and fauna getting overgrown in the village. Cllr. C Spinks will undertake addressing this come autumn.
- Cllr. K Stevens raised a list of highways issues in the village. Correspondence has been sent to the clerk to be actioned. A complete survey from the junction of Mere Road right the way through to Woodrising Village needs to be completed. Clerk to contact Scoulton's NCC Councillor to ask for advice on how to obtain a road survey.
- Fly tipping There has been fly tipping on private land. It's been moved to behind the bins at the Village Hall. Councillors to remove and dispose of properly.
